FACTS SUPPORTING PROBABLE CAUSE:

On 02-22-2016 at approximately 2347 hours, I was dispatch to Bucky's Casino (1500 East Highway 69 - # B) for a report of a possible criminal damage. The Complainant, Bucky's Casino Security Officer Juan Carlos Gallo advised Prescott Communications Dispatch that a male subject had just ripped an exterior sign (Casino Shuttle Sign) and was last seen walking into the Prescott Resort.

I arrived on scene and made contact with Security Officer Gallo at the security podium inside of Bucky's Casino. I asked Gallo to tell me what happened. Gallo said that he was doing his security rounds of the parking lot when he heard a loud noise coming from the walkway between the Prescott Resort and Bucky's Casino. When Gallo looked in that direction, he saw two male subjects, one wearing a dark jacket and dark jeans and the other wearing blue jeans and a dark jacket. Both subjects were seen entering the Prescott Resort through the front entrance.

When Gallo went over to the walkway area, he noticed a "Casino Shuttle Sign" that had damaged and was now laying on the sidewalk. Gallo took possession of the sign and noticed that the sign had been ripped off an exterior wall of the casino. Gallo then went inside the casino and advised the Casino Shift Manager of the damage. I asked Gallo if he would be willing to aid in prosecution for Disorderly Conduct (13-2904.A.1) and he said yes.

Casino Shift Manager and security staff advised me that the subject who ripped off the sign (and matched the physical and clothing description given by Gallo) was captured on casino surveillance video ripping off the sign at approximately 2337 hours. Casino security informed me that the subject was still in the casino playing at one of the card tables. The subject was contacted by casino security and asked to enter the Inspector's Office for questioning.

I followed casino staff into the Inspector's Office and I identified myself to the male subject, whom I later identified as Blaze Lawrence Baggs via his Arizona Driver's License. I advised Baggs that I was investigating a report of Criminal Damage and Theft of a casino sign. I asked Baggs if he knows what I was referring to and he said no. I advised Baggs that I had reasonable suspicion of his involvement in the damage and theft of the sign. I also advised Baggs that I would be reviewing the security video myself to determine his involvement in this investigation.

Baggs was moved into another room while I reviewed the video. (the following is a summary of the video that was seen) On the video I saw a male subject that matched Baggs' physical and clothing description walk up to the casino shuttle zone doors and stand for about a minute. Then Baggs is seen reaching over to a "Casino Shuttle" sign on the wall in front of him. Baggs attempts to tear down the sign but was unable to at first. Baggs then reached for the sign again and was able to tear it off the wall causing damage to the sign and wall. Baggs then kept the sign in his possession and walked down the walkway while waiting for a friend. Once Baggs friend meets up with him, Baggs shows his friend the sign and the two walk towards the Prescott Resort. Baggs is then seen tossing the sign into the air causing it to land on the ground and become more damaged. The Criminal Damage and Theft occurred at approximately 2337 hours on 02-22-2016.

Baggs was brought back into the Inspector's Office and I advised him that based on the information that I saw on the video, and the statement given to me by Security Officer Gallo, Baggs was being placed under arrest for Disorderly Conduct. The Criminal Damage and Theft charges will be forwarded for Federal Jurisdiction Review. Baggs was placed into handcuffs which I checked for proper tension and double locked. Baggs was given a Permanent Ban from all Yavapai Casino by casino staff and given copies of all related paperwork.

I transported Baggs to the Yavapai County Sheriff's Office - Prescott Jail where he was booked for Disorderly Conduct (ARS 13-2904.A.2). The Criminal Damage (ARS 13-1602.A.1) and Theft (ARS 13-1602.A.1) are assimilated from state violations and will be charged federally at a later date. Baggs was booked into jail without further incident.
