SYNOPSIS

On 05/16/16 at approximately 1510 hours, Jonathan Lowe committed public urination or defecation by defecating in the front yard at 16191 W. Mohave St. in view of the public.

NARRATIVE

On 05/16/16 at approximately 1527 hours, I responded to a call for service at 16191 W. Mohave St. Goodyear, AZ regarding public defecation on private property.

Upon my arrival I was met by Andrea Waters who lived at [REDACTED]. I recorded the interview of Andrea on my city issued digital recorder. She stated that a news van parked in front on her residence for approximately 40 minutes when a reporter exited the van. She stated that she immediately recognized the reporter as Jonathan Lowe from TV news. She observed Jonathan walk around and pick up several papers from the street. He then walked across the street to 16191 W. Mohave St., approach the side of the front yard, squat while leaning against the wall of the residence and proceeded to defecate in the yard of the residence. Jonathan then stood up and walked back to his news van. Andrea stated that if Jonathan had knocked on their door, she would've let him use their bathroom.

I contacted Jonathan Lowe in his news van parked on 161st Ln. I recorded the interview of Jonathan on my city issued digital recorder. As soon as I contacted Jonathan he stated, "I know what you want to talk to me about. I've been feeling very sick and I've been stuck in this van all day. So, I went over to that person's yard and took care of business. Those people who called on me just wanted to start problems." I told him that there was a Fry's Marketplace less than a mile away where he could have used the restroom. Jonathan stated that he couldn't leave the area. I advised Jonathan that since he defecated in a public area he was going to be arrested for the city code of public urinating or defecating.

Jonathan was taken into custody without incident and transported to the station for processing. Jonathan was cited to Goodyear Municipal Court for public urinating or defecating and was released from our custody.

I impounded the digital recordings into Goodyear Property.

Officer Ross took three photographs of the scene and impounded them into Goodyear property.

I have nothing further to add at this time.

This concludes my involvement in this matter.
