**PHOENIX** – As the new school year gets underway, the Governor's Office of Youth, Faith and Family is announcing the launch of the "Healthy Families – Healthy Youth" substance abuse prevention pilot program for seventh grade youth and their families.

The pilot program will run in all 15 counties throughout the month of September offering early

education and proven best practices across the state of Arizona.

The average age when Arizona youth begin to use an addictive substance is now 13 years old — and, with 90 percent of addicts starting to smoke, drink or use other drugs prior to age 18, it is clear that that early invention and education is a must.

"The best way to treat addiction is to get ahead of the problem and prevent it," stated Governor Ducey. "Bringing families together and educating them about the realities of substance abuse is one of the best ways to do that."

"One thing is clear: we must prevent the first use," stated Debbie Moak, director of the Governor's Office of Youth, Faith and Family. This pilot program is one of the many steps we're taking to let people know that they don't have to fight addiction alone."

Good Wednesday morning. A prosecutor from the Maricopa County Attorney's Office and a former prosecutor from that office have raised concerns about law enforcement and forensic examiners adopting and supporting the Start by Believing campaign. Both have stated that this message runs counter to the presumption of innocence and opens the investigation up to defense challenges. They are sharing these concerns with agencies that have adopted the SBB message, and in one communication, even threatened to serve as defense experts to challenge the investigations coming out of these agencies as biased.

Their argument appears to be based on the belief that the Start by Believing movement promotes believing victims throughout the entire criminal justice process, what I would call blind belief. This is not the message that End Violence Against Women International provides in their trainings or materials nor supports when espoused by other individuals or organizations.

It is called START by Believing for a reason. We do seek to counter the fear victims have of not being believed, and it is a community message designed to change our response as family and friends of a victims however it is also designed to change the respone of law enforcement and other criminal justice professionals to create an environment that victims can feel or sense is safe to report. Research is clear that the fear of not being believed is a primary concern for victims and a major reason why they often do not report to authorities or anyone else. This is the same philosophy that lead to the creation of Family Advocacy Centers - we want victims to feel safe and in a supportive environment, to report what happened to them and stay engaged with the criminal justice process so we can hold perpetrators accountable.

Yet there are pragmatic reasons for the SBB message as well. For law enforcement, it is a tactic that may be extremely helpful in gathering information. Victims are not likely to share much information with an officer they think does not believe them. More information is clearly better than less, and once the information is obtained, it can then be evaluated as to it value and credibility. We teach that in a criminal investigation of sexual assault, that law enforcement should follow the evidence, but the only way to get that evidence in the form of a thorough victim statement is to Start by Believing. If the case is weak, then a decision from the prosecution to not take it forward is appropriate. No one wants to see a person tried for something they didn't do, and our system has a number of very important checks and balances throughout the process to safeguard against that possibility. Any detective who blindly believes a victim, contrary to evidence, should be aggressively challenged in court, but the reality is a prosecutor would not permit it to get that far.

I encourage all in Arizona who have adopted the Start by Believing message and campaign not only their agency, but also for their community, to consider that we support the rights of any defendant in the process in fact, because this is such a powerful information gathering tactic, it is also in the best interest of a defendant who is innocent of the allegations. The best way to get to the truth of what happened is to conduct a thorough investigation. This is how I train on SBB and how EVAWI presents it.

The Start by Believing message is a legitimate tactic in sexual assault cases, along with new approaches to victim interviewing based on the neurobiology of trauma, the adoption and application of victim rights (one of which is the right for victims to be treated with respect and dignity), and the utilization of victim advocacy throughout the entire criminal justice process. Throughout the long history of criminal justice response to sexual assault, it is clear that we have proceeded from the philosophy of Start by Doubting. While we are not suggesting anything that would erode the fundamental belief in a presumption of innocence, we are in fact advocating for an approach that will lead to better investigations, a protection of victim rights, and the first real opportunity to change our societal environment in which those who sexually assault typically do so with impunity.

On the Start by Believing website (<u>www.startbybelieving.org</u>), under the menu tab "The Message" there is a document titled, "Can I Really Say That?" which helps explain our position with respect to this campaign. I have also attached that document to this e-mail.

I would agree with those who say that these cases are challenging, but I disagree that a detective - whose agency has supported and adopted the SBB message and tactic is going to lose credibility in cross examination by defense attorney witnesses. Talented attorneys will always find a way to attack an investigate, but that does not mean the argument is correct or that the position cannot be defended soundely.

I bring this to each of you as you have supported the concept of Start by Believing. Because you are hearing from individuals seeking to derail this campaign, I ask you to consider what it really is — and is not — about, and how the training is actually being presented by EVAWI.

Good Wednesday morning. A prosecutor from the Maricopa County Attorney's Office and a former prosecutor from that office have raised concerns about law enforcement and forensic examiners adopting and supporting the Start by Believing campaign. Both have stated that this message runs counter to the presumption of innocence and opens the investigation up to defense challenges. They are sharing these concerns with agencies that have adopted the SBB message, and in one communication, even threatened to serve as defense experts to challenge the investigations coming out of these agencies as biased.

Their argument appears to be based on the belief that the Start by Believing movement promotes believing victims throughout the entire criminal justice process, what I would call blind belief. This is not the message that End Violence Against Women International provides in their trainings or materials nor supports when espoused by other individuals or organizations.

It is called START by Believing for a reason. We do seek to counter the fear victims have of not being believed, and it is a community message designed to change our response as family and friends of a victims however it is also designed to change the respone of law enforcement and other criminal justice professionals to create an environment that victims can feel or sense is safe to report. Research is clear that the fear of not being believed is a primary concern for victims and a major reason why they often do not report to authorities or anyone else. This is the same philosophy that lead to the creation of Family Advocacy Centers - we want victims to feel safe and in a supportive environment, to report what happened to them and stay engaged with the criminal justice process so we can hold perpetrators accountable.

Yet there are pragmatic reasons for the SBB message as well. For law enforcement, it is a tactic that may be extremely helpful in gathering information. Victims are not likely to share much information with an officer they think does not believe them. More information is clearly better than less, and once the information is obtained, it can then be

evaluated as to it value and credibility. We teach that in a criminal investigation of sexual assault, that law enforcement should follow the evidence, but the only way to get that evidence in the form of a thorough victim statement is to Start by Believing. If the case is weak, then a decision from the prosecution to not take it forward is appropriate. No one wants to see a person tried for something they didn't do, and our system has a number of very important checks and balances throughout the process to safeguard against that possibility. Any detective who blindly believes a victim, contrary to evidence, should be aggressively challenged in court, but the reality is a prosecutor would not permit it to get that far.

I encourage all in Arizona who have adopted the Start by Believing message and campaign not only their agency, but also for their community, to consider that we support the rights of any defendant in the process in fact, because this is such a powerful information gathering tactic, it is also in the best interest of a defendant who is innocent of the allegations. The best way to get to the truth of what happened is to conduct a thorough investigation. This is how I train on SBB and how EVAWI presents it.

The Start by Believing message is a legitimate tactic in sexual assault cases, along with new approaches to victim interviewing based on the neurobiology of trauma, the adoption and application of victim rights (one of which is the right for victims to be treated with respect and dignity), and the utilization of victim advocacy throughout the entire criminal justice process. Throughout the long history of criminal justice response to sexual assault, it is clear that we have proceeded from the philosophy of Start by Doubting. While we are not suggesting anything that would erode the fundamental belief in a presumption of innocence, we are in fact advocating for an approach that will lead to better investigations, a protection of victim rights, and the first real opportunity to change our societal environment in which those who sexually assault typically do so with impunity.

On the Start by Believing website (<u>www.startbybelieving.org</u>), under the menu tab "The Message" there is a document titled, "Can I Really Say That?" which helps explain our position with respect to this campaign. I have also attached that document to this e-mail.


I would agree with those who say that these cases are challenging, but I disagree that a detective - whose agency has supported and adopted the SBB message and tactic is going to lose credibility in cross examination by defense attorney witnesses. Talented attorneys will always find a way to attack an investigate, but that does not mean the argument is correct or that the position cannot be defended soundely.

I bring this to each of you as you have supported the concept of Start by Believing. Because you are hearing from individuals seeking to derail this campaign, I ask you to consider what it really is — and is not — about, and how the training is actually being presented by EVAWI.



**PHOENIX** — Governor Doug Ducey today announced the members of the Arizona Sexual Assault Evidence Collection Kit Task Force, a bipartisan coalition of victims advocates, law enforcement officials and policy makers tasked with addressing the injustice of untested rape kits throughout Arizona.

Throughout the country – including Arizona – crime labs struggle to keep up with timely testing of the kits, resulting in a backlog of 2,300 untested kits in Maricopa County alone.

"For too long, women across our state have awaited justice for the despicable crimes inflicted upon them, while predators evade the law looking for their next victim," said Governor Ducey. "We must do everything in our power to stand up for those who've been victimized — and that means bringing to bear every resource and taking every necessary action to identify their assailants and lock them behind bars before they harm anyone else."

Governor Ducey charged the task force with multiple responsibilities, which include: providing legislative recommendations to ensure every kit is tested in a timely manner; developing a statewid standard process for testing protocols of the kits; developing a statewide tracking system for the kits; and development of a public education plan to assist sexual assault victims.

<u>Governor Ducey established the task force by Executive Order</u> on January 11, 2016 to address a ke priority in his 2016 State of the State address.





I do understand that the grant cycle is competitive and I am looking forward to reviewing the applications.

It has been a very sad week in Yavapai County. One AmeriCorps member who had planned to renew her position with the Senior Peer Program of West Yavapai Guidance Clinic was very distraught to hear of the granting decision. As a Senior Citizen, with little notice she lost her purpose and income. Another AmeriCorps member who was planning to renew with Casa 4Kids stated over and over to Ivy "what am I going to do?" With this decision, she lost her living allowance and her health insurance.

I could go on and on regarding the losses we have listened to people and organizations express. Merilee,

As you know, submitting an application for AmeriCorps funding through the Governor's Commission on Service and Volunteerism is competitive and funds programs for a three year cycle. There is no guarantee of continued funding from cycle to cycle in a formal, competitive process open to new and former applicants. This year's Request for Grant Application resulted in the receipt of many applications which requested almost double the amount of funds available.

Administering the AmeriCorps grant solicitation process and meeting the Federal regulatory and State statutory requirements involves time with all the complexities of the process. While two weeks' notice before the contract start date poses difficulty for applicants, even though we do our very best, our options can sometimes be limited to provide notification any earlier.

We do understand and acknowledge the difficulty this has caused for you and MATFORCE.

Additionally, with the new administration, interest has been expressed in finding ways to expand AmeriCorps in Arizona. We are currently exploring available options to better leverage AmeriCorps resources at the national level.

I understand through Sarah Bean that you've already scheduled a file review, which is welcomed.

Hi Bob,

I made some of the toughest phone calls I have ever made in my life last night to our AmeriCorps Partners regarding the decline of our AmeriCorps grant application.

We had multiple AmeriCorps members who had plans to renew for another term, these people will now lose their living allowance and health insurance with a two week notice.

This decision is devastating people's lives and the mission of multiple organizations in Yavapai County.

Following are some of the organization who had plans to continue excellent work through their AmeriCorps members: West Yavapai Guidance Clinic, Senior Peer Program, Prescott Area Woman's Shelter, Yavapai Big Brothers/Big Sisters, CASA 4Kids, Yavapai Reentry Project, Beaver Creek Transit, Verde River Greenways, Yarnell Recovery Group. Based on the focus area of substance abuse we had asked a majority of our partners to change the responsibilities of the AmeriCorps member to address this issue. We had recruited multiple new partnering agencies including Disabled American Vets (DAV), Steps to Recovery, and the Teen Launch Pad.

I spoke with Ben Olsen, who did receive AmeriCorps slots in Yavapai County. He said he could possibly find a position for one Partner, Prescott Area Shelter Services, which fills a small hole in a gaping wound for Yavapai County. Ironically Community Counts partnered with Prescott College to start SERVE Yavapai. We are the organization who brought the

VISTA program to Yavapai County and ran this project for several years before it went to Prescott College. Ben served as an AmeriCorps member under our organization. Even if Prescott College could fill the slots, how would this be fair to our organization?

Community Counts has successfully ran the AmeriCorps grant for nine years. The agency has done an excellent job and the positive impact in Yavapai County has been vast. Six of our AmeriCorps Members from this year are being hired as employees by the agencies they served. Based on our phone call and email prior to the release of the RFGA, I applied under MATFORCE opposed to Community Counts and again we refocused the program to primarily address substance abuse issues. The effect of this decision on our agencies is also huge. It adversely effects our operating income and the work and salaries of staff. I know we have a unique structure with two agencies, but the quality and impact would not have changed with the grant being under MATFORCE.

We will be requesting a file review and we also are asking Partners and Members to write letters to share the impact that this decision will have on them. Something is wrong with our granting system when organizations receive two weeks' notice for decisions that have this type of impact.

I am sad and bewildered and simply hurt by the devastation to our County that will result from this decision. Substance abuse prevention is key for our communities. If there are any possible solutions or alternatives to this decision, I would greatly appreciate it.

Beaver Creek Transit (BCT), a dba of the Beaver Creek Adult Center, was devastated to hear last night that we would not have an AmeriCorps member starting on September 1. Our stipended volunteer was included in the MATFORCE of Yavapai Coalition's application for the AmeriCorps State Grant Program which was just excluded from funding. Without the continued assistance of our member, the assistance that we provide to those in need will be cut in half.

We are a small organization of volunteers working together to distribute food and information about support services to those in need in the Beaver Creek area. The area includes the unincorporated communities of Rimrock, Lake Montezuma and McGuireville which are north of Camp Verde. A part time AmeriCorps member is our only "paid" employee. His youth and energy are of enormous benefit to our clients and to the rest of us volunteers who are mostly retirees. He keeps our vehicles running and takes many of the more difficult driving routes.

Last year our volunteer drivers made more than 900 food deliveries from the Camp Verde 7<sup>th</sup> Day Adventist Church Food Bank, delivered Meals on Wheels for the Verde Valley Senior Center in Cottonwood, drove a weekly van run to the Cornville Food Bank located in the First Southern Baptist Church, and made two weekly van runs to area grocery stores. In addition we do individual transport to shopping for those who need more assistance and have begun to work with the Yavapai Food Council at the Beaver Creek School Food Bank located in Rimrock. Many of our services are used by seniors or the disabled of all ages. Our priority clients are individuals with no or limited transportation or those whose health needs make shopping or food bank assistance necessary. We also drive residents to medical appointments, counseling, physical therapy and banking as vehicles and volunteer drivers are available.

Our clients include people whose income is marginal, people who have mental health issues, and people who took care of their families and helped others for many years. Residents of all ages receive food and assistance flyers from us.

Two weeks ago Beaver Creek Transit Food Delivery Service received Arizona Community Foundation of Yavapai County acknowledgment for the transformative level of our service. We want to be able to continue to offer the same or improved level of service to this community.

Thank you for your re-consideration of the MATFORCE grant application.

Therefore, the AmeriCorps staff over the past 2 years has been instrumental in the growth we have achieved serving those adults 60 and beyond.

Disaddon House Every day 10,000 people turn 65 and in the Prescott area we already house one of the larger groups of older adults in the State of Arizona. As a rural community our older population tends to be isolated and lonely which translates to increased depression <u>THillside Center</u> making them more vulnerable to suicide.

Our program has grown from 11 volunteers in 2013 to 49 in 2015. During the same 33 two year time period new participants have tripled, group meeting attendance is up 30% and educational community presentations have doubled. None of this would have been possible without AmeriCorps volunteers.

ORuth Street Clinic

Because the theme this year was working more aggressively with substance abuse our program fit the bill to a tee. Last year we provided 14 presentations on Prescription Medications and the Older Adult; provided 2800 pieces of educational materials to the public, especially older adults, on the use and abuse of prescription medications; provided radio commercials and news articles in the Daily Courier on the topic.



Hi Debbie,

I hope this email finds you well.

I am writing to see if you are available to meet with the Co-Chairs and Executive Director of MATFORCE, our Yavapai County Substance Abuse Coalition, during the afternoon of Thursday, July 23. We are requesting the meeting to discuss with you our concern over our grant funding from the Strategic Prevention Framework Partnerships for Success (SPF PFS). All three of us reside in northern Arizona and will be in Phoenix on that date.

For the past two years MATFORCE has had a contract with NARBHA for PFS funding at \$125,000 annually (\$14,000 of the amount was paid by NARBHA to a program evaluator). In the original award letter we received from NARBHA it states that the PFS grant is a five-year award. A copy of our award letter is attached.

We were very recently notified that the funding will no longer be distributed through NARBHA. No one can give us a clear answer on whether we will continue to receive the funds as awarded to our coalition nor can anyone tell us how the funds are to be distributed. This uncertainty is concerning as the MATFORCE Board of Directors recently approved our budget for fiscal year 2015-16 dependent upon our receipt of the SPF PFS funds.

The two Co-Chairs of MATFORCE, Doug Bartosh (the Cottonwood City Manager) and I, along with our Executive Director Merilee Fowler, would appreciate the opportunity to meet with you so that we can get to the bottom of this funding uncertainty and report back to our Board in a timely manner.

# Manufacturing Consent -- to Legal Marijuana

In this political season, the results of polling have proven as problematic as they have consequential. Questions of validity increasingly plague polls at the very moment that the body politic most bends to their will (or to that of the media outlets reporting on them).

Moreover, media increasingly adopt a strategy of first framing and then reporting public attitudes, at times appearing to shape polling outcomes while claiming to be merely mirroring them.

A case in point is the latest polling news on public attitudes towards legal marijuana, as <u>reported</u> by the *Washington Post*. Support has reached its highest level ever, according to the latest <u>survey</u> conducted by the *Associated Press* in conjunction with the National Opinion Research Center (NORC), reaching 61 percent of 1,042 respondents in favor.

But there is less here than meets the eye. For instance, the previous high point of approval ratings, 58 percent as <u>detected</u> by Gallup, is a finding within this poll's margin of sample error (3.9 percent). That is, the result represents, technically, "no change" from a statistical point of view.

But that was not the perspective of the media, whose enthusiasm approached "agenda journalism," the kind that celebrates every outcome favoring the journalist's preferred stance, while denigrating or ignoring contrary evidence.

They should have been more cautious. Consider that of the 639 people who supported legal marijuana, only 33 percent of them thought access should be "unrestricted," while for 24 percent, their support was contingent on there being "a medical prescription."

The framing of this last response is itself misleading, in that the question illegitimately implies that marijuana is an "approved" medication, able to be prescribed, which is true nowhere in the country.

Further, the poll's demographics are suspect, such as in their assignment of political affiliation. In this poll, only 35 percent of respondents are either "Republican or Lean Republican." The comparable Democratic percentage is set at 48 percent.

Given the finding in <u>Quinnipiac</u> polling that Democratic support in Colorado for legal marijuana (74 percent) is higher than that of Republicans (36 percent), this 13-point lean towards Democrats may shade results.

But the most surprising feature of the sample can be found with regards to employment. Fully 43 percent of respondents are not employed (school-aged 18-24 year olds are only 12 percent of the total).

This distribution may be a function of the real Achilles heel of the <u>survey</u> – the response rates, which attained a "cumulative response rate" of only 10.5 percent. That is, the survey had to winnow through a hundred contacted persons in order to measure the actual attitude of fewer than eleven. A similar, largely hidden fault now threatens nearly all political polls.

The lesson is that a survey meant to represent overall American attitudes has non-response rates that may yield a non-representative group of people – here, it is those not in the workforce, and hence, available for surveys such as this. It is possible that people not in the workforce have different attitudes regarding the acceptability of drug use than do the employed, a conjecture <u>buttressed</u> by the strong association between actual drug use and non-employment status.

There is finally the selective reporting by the media on the contents of the poll. Only the positive marijuana attitudes were reported, while the actual survey contained considerably more news, and much of it negative regarding legal drugs.

First, a remarkable 43 percent reported "a relative or close friend" with a substance use problem. Moreover, several Administration positions regarding the current epidemic of opiate dependency and overdose deaths did not receive support.

Fully 67 percent thought that doctors were not "a cause or only a minor cause" for the current epidemic of opiate dependency and overdoses, notwithstanding Administration arguments to the contrary. And while distributing the overdose antidote Naloxone was supported, 57 percent believed that it should require a doctor's prescription. (Regrettably, a much-needed policy to reduce the drug supply was not a provided survey question option.)

Nearly 70 percent agreed that drug use treatment needs improvement, yet 61 percent wanted more effort to "crack down on drug dealers" (and 53 percent supported "cracking down on users"), running contrary to Administration sentiments that "we can't arrest our way out of the drug problem."

Finally, even though there are now multiple advocacy calls for the government to establish "safe" injection facilities or even the provision of heroin itself for heroin treatment, only 7 percent (69 people) in this poll thought that heroin or cocaine should be legal, while 73 percent of even those supporters thought that there should be "restrictions."

None of these issues or responses was mentioned in the *Post* story. Instead, we find the typical self-confirming spiral regarding marijuana legalization. In <u>Gallup</u> polls, support for legal marijuana hovered in the 30 percent range until 2009, when it finally rose higher than 40 percent. Since then, a steady drumbeat of news accounts has relentlessly driven higher the attitudes that are conducive to Obama Administration positions, followed by "news" chronicling this higher public support, as ostensibly shown by polls.

This polling/reporting news cycle, one realizes, owes more to politics than to science.



Hi Bob,

I made some of the toughest phone calls I have ever made in my life last night to our AmeriCorps Partners regarding the decline of our AmeriCorps grant application.

We had multiple AmeriCorps members who had plans to renew for another term, these people will now lose their living allowance and health insurance with a two week notice.

This decision is devastating people's lives and the mission of multiple organizations in Yavapai County.

Following are some of the organization who had plans to continue excellent work through their AmeriCorps members: West Yavapai Guidance Clinic, Senior Peer Program, Prescott Area Woman's Shelter, Yavapai Big Brothers/Big Sisters, CASA 4Kids, Yavapai Reentry Project, Beaver Creek Transit, Verde River Greenways, Yarnell Recovery Group. Based on the focus area of substance abuse we had asked a majority of our partners to change the responsibilities of the AmeriCorps member to address this issue. We had recruited multiple new partnering agencies including Disabled American Vets (DAV), Steps to Recovery, and the Teen Launch Pad.

I spoke with Ben Olsen, who did receive AmeriCorps slots in Yavapai County. He said he could possibly find a position for one Partner, Prescott Area Shelter Services, which fills a small hole in a gaping wound for Yavapai County. Ironically Community Counts partnered with Prescott College to start SERVE Yavapai. We are the organization who brought the VISTA program to Yavapai County and ran this project for several years before it went to Prescott College. Ben served as an AmeriCorps member under our organization. Even if Prescott College could fill the slots, how would this be fair to our organization?

Community Counts has successfully run the AmeriCorps grant for nine years. The agency has done an excellent job and the positive impact in Yavapai County has been vast. Six of our AmeriCorps Members from this year are being hired as employees by the agencies they served. Based on our phone call and email prior to the release of the RFGA, I applied under MATFORCE opposed to Community Counts and again we refocused the program to primarily address substance abuse issues. The effect of this decision on our agencies is also huge. It adversely effects our operating income and the work and salaries of staff. I know we have a unique structure with two agencies, but the quality and impact would not have changed with the grant being under MATFORCE.

We will be requesting a file review and we also are asking Partners and Members to write letters to share the impact that this decision will have on them. Something is wrong with our granting system when organizations receive two weeks' notice for decisions that have this type of impact.

I am sad and bewildered and simply hurt by the devastation to our County that will result from this decision. Substance abuse prevention is key for our communities. If there are any possible solutions or alternatives to this decision, I would greatly appreciate it.


