WHISTLEBLOWER CHRONICLES

- 07/11/1997 George Bush appoints **George Tenet** Director of the CIA.
- 11/12/1998 NSA begins development of data harvesting and data mining technology, THINTHREAD.
- 09/14/1998 **Dennis Montgomery** and **Warren Trepp** form eTreppid Technologies.

- 09/13/2002 Roark tried to notify her superior, then-Chairman of the House Permanent Select Committee on Intelligence, **Porter Goss**. She also attempted to contact **William Rehnquist, the Chief Justice of the United States Supreme Court** at the time.
- 01/02/2004 **Phil Gordon** elected to Mayor of Phoenix, Arizona.
- 11/15/2003 NSA Inspector General (IG) had declared Trailblazer an expensive failure. It cost more than 1 billion dollars.
- 12/15/2003 FBI delivers Blade servers to eTreppid.
- 01/10/2004 The NSA supplied source code to eTreppid to enhance existing product MEDUSA (data harvesting), part of TRAILBLAZER program.

- 02/27/2006 CIA calls Dennis Montgomery and discloses search warrant, and demands data harvesting technology and harvested content be hidden.
- 02/28/2006 8 Armed FBI agents raided the homes of Dennis Montgomery. The same people who had filed the complaint with the DOD Inspector General in 2002. Binney claims they pointed guns at his wife and himself. Wiebe said it reminded him of the Soviet Union. None of these people were charged with any crimes. In November 2007, there was a raid on Drake's residence. His computers, documents, and books were confiscated. The Justice Department's actions may have been prompted by a letter sent to the Department by City of Phoenix Mayor Phil Gordon on April 4, 2008. In his letter, Mayor Gordon requested that the Justice Department direct the Civil Rights Division and the Federal Bureau of Investigation to initiate an investigation of the Sheriff for "potential civil rights investigations." [Complaint, Exhibit D] The letter was sent after Mayor Gordon's assistant (and a named plaintiff in this case), Jessica Rodriquez, allegedly was stopped and questioned by a MCSO deputy.

If the Justice Department determines that the Sheriff and the MCSO have engaged "in a pattern or practice of conduct . . . that deprives persons of rights, privileges, or immunities secured or protected by the Constitution or laws of the United States," it may institute a civil action to "obtain appropriate equitable and declaratory relief to eliminate the pattern or practice." 42 U.S.C. § 14141 (a)-(b).

Accomplishment of its law enforcement and immigration duties. [Sheriff's and MCSO's Response to Plaintiffs' Motion for Class Certification, p. 11-12]8

At a minimum, a temporary stay of the proceedings in this case pending the outcome of the Justice Department's investigation is warranted pursuant to the separation of powers doctrine.
