General Report

AT APPROXIMATELY 2322 HOURS, I, TROOPER WILLIAMS, #10477, OBSERVED A WHITE FORD PICKUP TRUCK BEARING ARIZONA LICENSE PLATE CK89257, TRAVELING EASTBOUND ON STATE ROUTE 202 IN THE NUMBER FOUR LANE AT APPROXIMATELY MILE POST 17. THE VEHICLE CAUGHT MY ATTENTION BY DRIVING OUT OF ITS LANE WITH BOTH RIGHT SIDE TIRES IN THE RIGHT SHOULDER. AS I CONTINUED OBSERVATION, THE VEHICLE SLOWLY DRIFTED BACK INTO ITS LANE AND THEN CONTINUED TO DRIFT TO THE LEFT UNTIL BOTH LEFT SIDE TIRES CROSSED INTO THE NUMBER THREE LANE. HE CONTINUED TO DRIVE PARTIALLY IN THE NUMBER THREE LANE FOR APPROXIMATELY 100 YARDS. HE BEGAN A SLOW DRIFT TO THE RIGHT SIDE UNTIL BOTH RIGHT-SIDE TIRES BEGAN CROSSING ONTO THE RIGHT SHOULDER. THE DRIVER CORRECTED HIS ACTION AND MANEUVERED HIS VEHICLE BACK INTO THE NUMBER FOUR LANE. AS I GOT CLOSE ENOUGH TO READ THE LICENSE PLATE, THE VEHICLE DRIFTED TO THE LEFT, DRIVING ON THE LANE DIVIDER LINE, HITTING THE ROAD BRAIL FOR APPROXIMATELY 50 YARDS. THE VEHICLE WENT BACK INTO ITS LANE AND DRIFTED LEFT, CROSSING THE LANE DIVIDER LINE A SECOND TIME AT WHICH POINT I INITIATED THE TRAFFIC STOP BY ACTIVATING MY EMERGENCY LIGHTS.

DRIVER CONTACT:

UPON CONTACTING THE VEHICLE ON THE PASSENGER SIDE, I IMMEDIATELY DETECTED THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE EMANATING FROM THE VEHICLE. I INTRODUCED MYSELF AS, TROOPER WILLIAMS WITH THE ARIZONA HIGHWAY PATROL AND INFORMED THE DRIVER OF THE REASON FOR THE TRAFFIC STOP. AT THAT TIME, I OBSERVED THE DRIVER TO HAVE BLOODSHOT AND WATERY EYES. PRIOR TO BEING ABLE TO COMPLETE EXPLAINING THE REASON FOR THE TRAFFIC STOP, THE DRIVER INTERRUPTED ME AND INFORMED ME THAT HE DROPPED HIS CELL PHONE AND WAS TRYING TO PICK IT UP AND THAT WAS THE REASON FOR THE DRIVING BEHAVIOR. THE DRIVER'S SPEECH WAS SLOW AND SLURRED AS HE EXPLAINED HIS ACCOUNT OF WHAT CAUSED HIS DRIVING BEHAVIOR. HE BEGAN ATTEMPTING TO PICK UP HIS CELL PHONE THAT WAS ON THE FLOOR BOARD OF THE DRIVERS SEATING AREA. WHILE THE DRIVER DID THIS, I WAS ABLE TO OBSERVE THE DRIVER TO HAVE DECREASED MOTOR SKILLS BY NOT BEING ABLE TO PICK UP PHONE AFTER SEVERAL ATTEMPTS. I ASKED THE DRIVER TO PROVIDE ME HIS LICENSE, REGISTRATION, AND PROOF OF INSURANCE. THE DRIVER HANDED ME HIS REGISTRATION AND INSURANCE CARD FOLLOWED BY HIS ARIZONA HOUSE OF REPRESENTATIVES IDENTIFICATION CARD. I ASKED THE DRIVER A SECOND TIME TO SEE HIS DRIVER'S LICENSE, WHICH HE DID. I WAS THEN ABLE TO IDENTIFY THE DRIVER AS COOK, DAVID, DATE OF BIRTH 05/15/1968 BY HIS VALID ARIZONA COMMERCIAL DRIVER'S LICENSE. I RETURNED TO MY VEHICLE TO CONDUCT A RECORD CHECK OF COOK'S LICENSE. WHEN I RETURNED TO COOK'S VEHICLE I ASKED HIM TO STEP OUT OF HIS VEHICLE, AT WHICH POINT HE TOLD ME, "NO, IM NOT GETTING OUT". HE STATED HE WAS JUST GETTING HIS PHONE THAT HE DROPPED AND THERE WASN'T ANY NEED FOR THIS. I TOLD HIM THAT I NEEDED HIM TO STEP OUT OF HIS VEHICLE SO I COULD ENSURE THAT HE WAS TELLING ME THE TRUTH, AND THAT HE WAS SAFE TO DRIVE. HE STATED, "DO YOU KNOW WHAT YOU'RE DOING SON? YOU'RE MAKING A MISTAKE". HE THEN STATED, "WHAT DO YOU WANT ME TO DO?". I REQUESTED HE STEP OUT OF HIS VEHICLE AND MEET ME AT THE BACK OF HIS TRUCK A SECOND TIME. COOK ASKED IF IT WAS SAFE. I STATED, "YES", AND HE EXITED HIS TRUCK. AS HE EXITED HIS TRUCK AND BEGAN WALKING TOWARDS THE BACK OF HIS TRUCK, HE STAGGERED AND USED THE SIDE OF HIS TRUCK TO BALANCE HIMSELF ONE TIME AS HE WALKED TO MEET ME.

STANDARDIZED FIELD SOBRIETY TESTS:

ONCE AT THE REAR OF HIS VEHICLE, I ASKED COOK IF HE WOULD BE WILLING TO CONSENT TO STANDARDIZED FIELD SOBRIETY TESTS TO ENSURE THAT HE WAS SAFE TO DRIVE. COOK STATED, "NO, I'M NOT GOING TO DO THAT". I INFORMED COOK THAT I COULD SMELL THE ODOR OF AN ALCOHOLIC BEVERAGE WHILE HE WAS IN HIS VEHICLE. I ALSO INFORMED COOK I COULD SMELL THE ALCOHOLIC BEVERAGE COMING FROM HIS PERSON. I INFORMED HIM HE HAD SLURRED SPEECH, BLOODSHOT WATERY EYES AS WELL AS DECREASED MOTOR SKILLS. I NOTIFIED COOK THAT IF HE WAS UNWILLING TO CONSENT TO, AND CONDUCT, THE STANDARDIZED FIELD DO THAT" AND, "FINE WHAT DO YOU WANT ME TO DO?". COOK WAS UNCOMPLIANT WHEN ATTEMPTING TO ADMINISTER FIELD

TROOPER WILLIAMS HORIZONTAL GAZE NYSTAGMUS:

I ATTEMPTED TO PLACE COOK INTO THE REQUIRED POSITION TO CONDUCT THE HORIZONTAL GAZE NYSTAGMUS TEST, HOWEVER HE REFUSED TO FOLLOW THE INSTRUCTIONS AS PROVIDED, KEEPING HIS FEET SHOULDER WIDTH APART, AND LEAVING HIS ARMS AT A RESTING HANG INSTEAD OF AFFIXED ALONG THE SIDE OF HIS PANTS, AS INSTRUCTED. AS I INFORMED COOK HE NEEDED TO GET INTO THE POSITION AS I WAS DEMONSTRATING AND EXPLAINING, COOK STATED, "THIS IS AS GOOD AS ITS GOING TO GET". I RE-INSTRUCTED COOK ON THE INSTRUCTIONS FOR THE TESTING POSITION. COOK THEN PLACED HIS HEELS TOGETHER KEEPING HIS TOES AT A WIDE ANGLE. I FURTHER STATED THAT HE NEEDED TO PLACE HIS TOES TOGETHER AS WELL AS HIS HEELS. COOK BROUGHT HIS TOES IN A FEW INCHES, STILL NOT FULLY ACQUIRING THE INTENDED POSITION FOR THE TEST. I BEGAN TO HOLD MY PEN AND FLASHLIGHT TO ATTEMPT FOR COOK TO AFFIX HIS EYES TO THE PEN AS INSTRUCTED. COOK WOULD NOT LOOK AT THE PEN, RATHER HE WAS JUST STARING ME IN THE EYES. I INSTRUCTED COOK TO LOOK AT MY PEN FOR A SECOND TIME AS HE CONTINUED TO IGNORE THE INSTRUCTIONS AND LOOK AT ME. I TRIED A THIRD TIME, BUT AS I BEGAN TO EXPLAIN THE INSTRUCTIONS, COOK COMPLETELY CAME OUT OF THE POSITION AND BEGAN TO TELL ME HE HAD BEEN HIT ON THE RIGHT SIDE OF HIS FACE ABOVE HIS RIGHT EYE TWO WEEKS PRIOR. I TOLD COOK TO GET BACK INTO THE INSTRUCTED POSITION SO I COULD CONTINUE WITH THE TEST. HE DID NOT, RATHER HE CONTINUED TO TELL THE STORY OF THE INJURY THAT OCCURRED TO THE SIDE OF HIS HEAD. I CONCLUDED ATTEMPTING TO PERFORM THE TEST AND CALLED FOR TROOPER BRIAN HOUCHENS, #7537, TO RESPOND TO MY SCENE, AS HE WAS MY ACTING SUPERVISOR AT THE TIME OF THIS INVESTIGATION. COOK STATED HE WANTED MY SERGEANT TO RESPOND TO THE SCENE. I TOLD HIM THAT WAS NOT GOING TO HAPPEN, BUT I HAD ANOTHER TROOPER RESPONDING THAT WAS MY ACTING SUPERVISOR. TROOPER DARIUS WINDELS, #10347, ARRIVED ON SCENE AT APPROXIMATELY 2346 HOURS, AT WHICH POINT COOK IMMEDIATELY BEGAN TO WALK TOWARDS HIM TO GREET HIM. TROOPER WINDELS INFORMED COOK THAT IT WAS MY SCENE AND TO NOT WORRY ABOUT HIM. WITH ANOTHER TROOPER ON SCENE, I ATTEMPTED FOR A SECOND TIME TO CONDUCT THE HGN TEST. AS I WAS ATTEMPTING TO GET COOK INTO THE INSTRUCTED POSITION AND TO AFFIX HIS EYES TO MY PEN, HE BEGAN TO COMPLAIN ABOUT MY LIGHT, STATING THAT IT WAS TOO BRIGHT. COOK WOULD NOT PERFORM THE TEST AS INSTRUCTED SO I MOVED ON TO THE WALK AND TURN TEST.

TROOPER WILLIAMS WALK AND TURN:

I ASKED COOK IF HE HAD ANY PHYSICAL DISABILITIES OR INJURIES THAT WOULD RENDER HIM UNABLE TO WALK OR BALANCE. COOK REFERENCED HIS RECENT HEAD INJURY THAT OCCURRED TWO WEEKS AGO. I BEGAN THE TEST BY PROVIDING ALL INSTRUCTIONS VERBATIM FROM THE DPS ALCOHOL INFLUENCE REPORT. AS I WAS GIVING THE INSTRUCTIONS AND ATTEMPTING TO PLACE COOK IN THE INSTRUCTED POSITION, HE ATTEMPTED IT WITH HIS LEFT FOOT IN FRONT OF HIS RIGHT INSTEAD OF THE INSTRUCTED MANOR OF RIGHT FOOT IN FRONT OF LEFT. COOK HAD TO BE RE-INSTRUCTED TO SWITCH HIS FEET TO THE CORRECT STARTING POSITION SIX TIMES. ONCE IN THE CORRECT STARTING POSITION WITH HIS FEET, COOK SWAYED AND USED HIS ARMS TO BALANCE BEFORE TAKING HIS RIGHT FOOT OUT OF THE INSTRUCTED POSITION TO BRACE HIMSELF TO PREVENT FROM FALLING OVER. COOK THEN STOOD WITH FEET SHOULDER WIDTH APART AND PLACED HIS HANDS IN HIS POCKETS. COOK WAS ONCE AGAIN INSTRUCTED TO RETURN TO THE DEMONSTRATED POSITION AT WHICH POINT HE STATED HE WANTED TO SEE ME DO THE WHOLE TEST FIRST. I EXPLAINED TO COOK HE NEEDED TO REMAIN IN THE POSITION, HOWEVER HE BEGAN PLACING HIS LEFT FOOT FORWARD, OPPOSITE OF WHAT WAS INSTRUCTED AND DEMONSTRATED. I ATTEMPTED TO CORRECT COOK AGAIN ON HIS POSITION, AT WHICH POINT COOK CAME OUT OF THE POSITION COMPLETELY, BECAME ARGUMENTATIVE, AND BEGAN TO RAISE HIS VOICE. TROOPER HOUCHENS, WHO HAD ARRIVED ON SCENE, BUT WAS STANDING OFF TO THE SIDE AS I ATTEMPTED THE FIELD SOBRIETY TESTS, OBSERVED COOK'S BEHAVIOR AND WALKED OVER TO THE SCENE TO ASSIST WITH THE INVESTIGATION.

TROOPER HOUCHENS STANDARDIZED FIELD SOBRIETY TESTS:

TROOPER HOUCHENS BEGAN SPEAKING WITH COOK ATTEMPTING TO CALM HIM DOWN. TROOPER HOUCHENS WAS SUCCESSFUL IN CALMING COOK DOWN, ALTHOUGH COOK CONTINUED TO BE UNCOOPERATIVE. TROOPER HOUCHENS WAS ABLE TO GET COOK TO CONTINUE PERFORMING STANDARDIZED FIELD SOBRIETY TESTS. TROOPER HOUCHENS OBSERVED SEVEN OUT OF EIGHT CLUES ON THE WALK AND TURN TEST, AND FOUR OUT OF SIX CLUES ON THE HORIZONTAL GAZE NYSTAGMUS TEST. TROOPER HOUCHENS INFORMED COOK HE WAS UNDER ARREST FOR DRIVING UNDER THE INFLUENCE AND TOOK HIM INTO CUSTODY AT APPROXIMATELY 0020 HOURS.

ARREST AND MIRANDA:

AT APPROXIMATELY 0020 HOURS, COOK WAS INFORMED HE WAS UNDER ARREST FOR DRIVING UNDER THE INFLUENCE AND TAKEN INTO CUSTODY. AT APPROXIMATELY 0027 HOURS, I READ COOK HIS MIRANDA RIGHTS VERBATIM FROM THE DEPARTMENT PROVIDED MIRANDA RIGHTS CARD. WHEN ASKED IF HE UNDERSTOOD HIS RIGHTS, HE VERBALLY STATED, "YES", AND FURTHER STATED HE WISHED TO SPEAK WITH AN ATTORNEY.

VEHICLE DISPOSITION:

AT APPROXIMATELY 0049 HOURS, COOK'S VEHICLE, A WHITE 2017 FORD F-250, WAS TOWED BY FIRST CLASS AUTOMOTIVE TRANSPORT. THE VEHICLE WAS IMPOUNDED FOR 30 DAYS PURSUANT TO ARS 28-3511.

FURTHER PROCESSING:

AT APPROXIMATELY 0040 HOURS, COOK WAS TRANSPORTED TO THE DPS KNUTSON STATION (KS). AT APPROXIMATELY 0105 HOURS, I ARRIVED AT KS WITH COOK IN CUSTODY. WHILE ASSISTING COOK OUT OF THE REAR OF MY PATROL VEHICLE, I STATED TO COOK TO

WATCH HIS HEAD AS HE STOOD UP TO EXIT MY PATROL UNIT. COOK STATED, "I'M FINE, DON'T WORRY, YOU'LL GET YOURS".

ATTORNEY CONTACT:

COOK WAS PROVIDED 20 MINUTES FROM APPROXIMATELY 0112 HOURS TO APPROXIMATELY 0122 HOURS, TO CONTACT LEGAL COUNSEL. COOK WAS PROVIDED A PRIVATE ROOM, A CURRENT PHONE BOOK, A LAND LINE, AS WELL AS HIS CELL PHONE. COOK TERMINATED HIS TIME TWO MINUTES EARLY STATING THAT HE WAS FINISHED.

ADMIN PER SE / IMPLIED CONSENT AFFIDAVIT:

AT APPROXIMATELY 0127 HOURS, COOK WAS READ THE ADMONITIONS VERBATIM FROM THE ADMIN PER SE / IMPLIED CONSENT AFFIDAVIT. WHEN ASKED IF HE WOULD CONSENT TO TESTS, COOK STATED HE WOULD NOT CONSENT TO ANY FORM OF TESTING. COOK WAS THEN READ THE FOLLOW UP ADMONITIONS VERBATIM. AS I BEGAN READING THE FOLLOW ADMONITIONS, COOK STATED HE DID NOT KNOW WHAT I WAS TALKING ABOUT. HE FURTHER STATED HE WAS NOT LISTENING COMPLETELY. I RE-READ THE ADMIN PER SE AT WHICH POINT HE VERBALLY STATED, YES, HE WOULD CONSENT TO TESTING.



If you were suspended pursuant to ARS 28-1385, the scope of the hearing will include only those issues specific in ARS 28-1385.
