I made contact with the subject in the alley to the store, who identified himself as Byron Dean Tolson. Byron advised me that he has bought several items at the store and was contemplating on buying a bed. He said that one of the employees told him that he was talking to loud on his cell phone and he needed to leave the store. Byron said that he left the store and was in the back waiting to talk to the maintenance worker.

I contacted the RP inside the store, Cheryl Sieck, the store manager. Cheryl confirmed that Byron has bought items in the store, but had not purchased the bed. She told me that Byron sits in the store for several hours not buying anything, She also stated that he contentiously asks her out on dates and she turns him down. She that she does not feel comfortable with in the store and wanted him trespassed.

I re-contacted Byron and advised him that Cheryl requested that he be trespassed from the store. I completed the trespass letter and served him with his copy. I advised him that the trespass was valid for one year from this date. Byron advised me that he understood and would not come back to the store.

I returned to the store and provided Cheryl with her copy of the trespass letter.
