

## ADDENDUM

A. Offense Location
DESERT AREA/ 99TH AVENUE AND CAREFREE HIGHWAY, MARICOPA COUNTY

**B1. Probable Cause Statement** 

ON DECEMBER 10, 1988, LISTED DEFENDANT DONALD LEE SCOTT REPORTED FINDING A DEAD BODY WHILE DRIVING IN THE DESERT AREA SOUTHWEST OF THE CAREFREE HIGHWAY AND 99TH AVENUE. SCOTT WAS ACCOMPANIED BY A COMPANION AND THEY DID TAKE DEPUTIES TO THE SCENE WHERE THE BODY WAS FOUND. DEPUTIES FOUND THAT A WHITE FEMALE WAS IN FACT DECEASED AND APPEARED TO HAVE BEEN SHOT MULTIPLE TIMES. SCOTT AND HIS COMPANION AND HIS VEHICLE A BROWN CHEVROLET 4 DOOR WERE PHOTOGRAPHED AND RELEASED FROM THE SCENE. THE SCENE WAS PROCESSED BY MCSO HOMICIDE DECTECTIVES AND MULTIPLE ITEMS OF EVIDENCE WERE RECOVERED. OF NOTE TO DETECTIVES WAS THAT THE BODY APPEARED TO HAVE BEEN RECENTLY KILLED. DETECTIVES ALSO NOTED THAT THE VICTIMS PANTS WERE BUTTONED BUT THE ZIPPER WAS ONLY PARTIALLY CLOSED. THE UNIDENTIFIED VICTIM WAS REMOVED AND TRANSPORTED TO THE MARICOPA COUNTY OFFICE OF THE MEDICAL EXAMINER FOR AUTOPSY. UPON EXAMINATION, THE FEMALE WAS FOUND TO HAVE SEVERAL GUNSHOT WOUNDS, ONE OF WHICH WAS DETERMINED TO HAVE BEEN IMMEDIATELY INCAPACITATING. A SEXUAL ASSAULT EXAMINATION WAS ALSO CONDUCTED. EVIDENCE OF RECENT TRAUMA WAS DISCOVERED ON THE INNER LEGS NEAR THE UPPER KNEES THAT CONSISTED OF BRUISING AND A SCRATCH. AN ABRASION WAS ALSO FOUND ON THE EXTERNAL GENITAL AREA. BIOLOGICAL SAMPLES WERE COLLECTED FROM THE VICTIM AND IT WAS LATER FOUND THROUGH LABORATORY TESTING THAT SEMEN WAS PRESENT IN THE VICTIMS VAGINA. FINGERPRINTS WERE TAKEN OF THE VICTIM AND SHE WAS POSITIVELY IDENTIFIED AS ANNE MARIE LEVEE. AN EXTENSIVE INVESTIGATION WAS CONDUCTED BY DETECTIVES AND THE LEADS WERE EXHAUSTED. THE LAST INFORMATION THAT THEY HAD WAS THAT ANNE LEVEE WAS LAST SEEN WITH A WHITE MALE WITH BROWN HAIR AND A MOUSTACHE IN A MAROON CAR. IN 2003, THE CASE WAS RE-EXAMINED AND DUE TO ADVANCES IN SCIENCE, THE BIOLOGICAL EVIDENCE WAS AGAIN SENT FOR ADDITIONAL DNA TESTING. A MALE PROFILE WAS EXTRACTED FROM THE SAMPLES TAKEN FROM THE VICTIMS VAGINA. THE SAMPLES WERE ENTERED INTO THE COMBINED DNA INDEX SYSTEM (CODIS). IN DECEMBER 2016, A REPORT WAS GENERATED BY THE ARIZONA DEPARTMENT OF PUBLIC SAFETY LABORATORY THAT THE UNKNOWN SAMPLE ENTERED INTO CODIS IN 2003 NOW HAD A DNA MATCH. THIS MATCH WAS REPORTED TO BELONG TO DONALD LEE SCOTT, DOB 07-31-1962. DETECTIVES EXAMINED THE CASE AND FOUND THAT THE MATCHED INDI-VIDUAL WAS THE FINDER OF ANNE LEVEE'S BODY. DETECTIVES CONDUCTED RESEARCH ON LISTED DEFENDANT AND FOUND THAT HE HAD AN EXTENSIVE CRIMINAL HISTORY OF ARRESTS FOR WEAPONS, STALKING, ASSAULT, HARRASSMENT AND ATTEMPTED SEXUAL ASSAULT. LISTED DEFENDANT WAS CONVICTED IN 2014 FOR AGGRAVATED HARASSMENT AND HE WAS SENTENCED TO TIME IN THE ARIZONA DEPARTMENT OF CORRECTIONS AND A DNA SAMPLE WAS OBTAINED AND ENTERED INTO CODIS REFERENCE THAT CONVICTION. AFTER THE CODIS HIT DETECTIVES OBTAINED A KNOWN DNA SAMPLE OF DONALD LEE SCOTT TO CONFIRM THE MATCH. THE SAMPLE WAS SENT TO THE ARIZONA DEPARTMENT OF PUBLIC SAFETY LAB FOR CONFIRMATION. IN JANUARY 2018, AZDPS LABORATORY CONFIRMED THAT THE SUBMITTED CONFIRMATION SAMPLE WAS FROM THE SAME INDIVIDUAL, DONALD LEE SCOTT. LISTED DEFENDANT WAS TAKEN INTO CUSTODY AND UNDER MIRANDA, HE TOLD DETECTIVES THAT HE WAS DRIVING IN THE DESERT WITH HIS COMPANION AND DID DISCOVER THE DEAD FEMALE. LISTED DEFENDANT DENIED EVERY HAVING ANY PHYSICAL CONTACT WITH THE BODY PRIOR TO FINDING IT, WHEN HE FOUND IT, OR AFTER HE NOTIFIED THE MARICOPA COUNTY SHERIFFS OFFICE. LISTED DE-FENDANT TOLD DETECTIVES HE NEVER GOT CLOSE ENOUGH TO THE BODY TO EVEN SEE ANY INJURIES ON THE VICTIM. LISTED DEFENDANT REPEATEDLY DENIED EVER KNOWING THE VICTIM, OR HAVING RECALLED HAVING SEXUAL INTERCOURSE WITH HER. LISTED DEFENDANT DENIES RAPING OR KILLING THE VICTIM BUT IS UNABLE TO PROVIDE ANY EXPLANTION ON WHY HIS SEMEN WAS FOUND WITHIN THE VAGINAL VAULT OF A DEAD FEMALE THAT HE FOUND DECEASED. WHEN QUESTIONED ABOUT HIS CRIMINAL HISTORY REGARDING CRIMES AGAINST WOMEN THAT HE WAS ARRESTED FOR, LISTED DEFENDANT WAS ABLE TO RECOUNT SPECIFIC DETAILS ON INCIDENTS YEARS PRIOR TO THIS HOMICIDE AND YEARS AFTER, BUT THESE ARRESTS ARE STILL FROM 20 YEARS AGO. THE COMPANION THAT LISTED DEFENDANT WAS WITH DURING THE DISCOVERY OF THE BODY WAS RECONTACTED AND ABLE TO PROVIDE ADDITIONAL INFORMATION. THE COMPANION STATED THAT THEY WERE IN THE DESERT FOR SEVERAL HOURS

THE COMPANION DID SAY THAT EITHER BEFORE OR AFTER THEY CONTACTED THE MARICOPA COUNTY SHERIFFS OFFICE, LISTED DEFENDANT DID STATE THAT THE VICTIM WAS INJURED ON HER FACE OR HER CHEST BUT CANNOT PRECISELY REMEMBER WHICH AT THIS TIME. LISTED DEFENDANT WAS BOOKED INTO THE 4TH AVENUE JAIL FOR FIRST DE-GREE MURDER AND SEXUAL ASSAULT.
