
Furthermore I accept what ever sentence this court places upon me.

Don had been on site several week's prior. His first assignment was to supervise, count and stock incoming lumber and hardware shipments. I would estimate the lumber he was responsible for was to be in the range of Two Million Dollars. He performed the task efficiently. The task was difficult with the Office calling 2-3 times a week, wanting to know how much lumber was on the job site, how much was used, and how much was not yet shipped. Also during this time he was assigned to supervise 20-25 workers in the building for Components for the future buildings.

Insulmost any buisness or industry, doing a good job is rewarded with more responsibility. This was the case with Don.
