COUNT 1 FRAUDULENT SCHEMES & ARTIFICES

On or between August 1, 2017 and March 1, 2019, **JEFFREY ALLAN MARCUSSEN**, pursuant to a scheme or artifice to defraud, knowingly obtained a benefit by means of false or fraudulent pretenses, representation, promises, or material omissions, in violation of A.R.S. §§ 13-2310, 13-2301, 13-701, 13-702, 13-811, and 13-801.

COUNT 2 THEFT

On or between, August 1, 2017 and March 1, 2019, **JEFFREY ALLAN MARCUSSEN**, without lawful authority, knowingly took control of property of the NBA Phoenix Suns with the intent to deprive the Suns Legacy Partners of such property, TO WIT: game tickets with an aggregate value of more than \$25,000 in violation of A.R.S. §§ 13-1802(A)(1)(H), 13-1801, 13-1801(B), 13-701, 13-702, 13-801, 13-811.

COUNT 3 FALSE RETURN

On or about April 12, 2018, **JEFFREY ALLAN MARCUSSEN**, knowingly prepared, presented or aided, procured or advised in preparing or presenting any return, affidavit, claim or other document which is fraudulent or is false as to any material matter, whether or not the falsity or fraud is with the knowledge or consent of the taxpayer authorized or required to present the return, affidavit, claim or document, in violation of A.R.S. §42-1127(B)(2), 42-1101.01, 13-701, 13-702, 13-703, 13-801 and 13-811.
